



Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to mainetfunded.com, and governs data collection and usage. This Privacy Policy explains the policies of Mainet Funded on the collection and use of the information we collect when you access www.mainetfunded.com (the “Service”). This Privacy Policy describes your privacy rights and how you are protected under privacy laws.

Collection and Use of Your Personal Information

When using our Service, you will be prompted to provide us with personal information used to contact or identify you. mainetfunded.com collects the following information:

- Usage Data
- First and Last Name
- Home Address
- E-mail address
- Phone Number
- Financial Information

Usage Data includes the following:

- Internet Protocol (IP) address of computers accessing the site
- Web page requests
- Referring web pages
- Browser used to access site
- Time and date of access

Mainet Funded collects billing and credit card information when customers purchase products and services. This data is utilized solely for transaction completion and payment processing. Personal information is collected only on a voluntary basis. Sharing with affiliates - Third-party Sharing

Tracking User Behavior

Cookies

- **Unclassified cookies.** Unclassified cookies are cookies that do not belong to any other category or are in the process of categorization.
